


AUCTION NOTICE

An open auction for sale of un-serviceable material will be held in the office of DFO(HQ) O/o Pr. CCF (WL) Talland Shimla on 20-01-2018 at 11.00 A.M. The interested parties/persons are requested to attend the auction proceeding on the scheduled date and time as per terms and conditions detailed below. The unserviceable materials list is also available on website [www.hp.forest.nic.in](http://www.hp.forest.nic.in) of this office and can be inspected on any working day during office hours in the site shown in the list.

Terms and Condition:

1. All the bidders are requested to deposit a sum of Rs.1000/- as security with DFO(HQ) O/o Pr. CCF (WL) Talland Shimla before start of public auction. The security of successful bidder shall be adjusted towards the accepted auction/bid amount. The security of others bidders shall be refunded after the auction is over.
2. The successful bidder is required to deposit 50% of the highest accepted bid amount and balance amount will have to be deposited within 3 days after date of auction. In case the highest bidder fails to deposit the amount the bid automatically shall stand forfeited and the bidder will not be allowed to lift the material. The undersigned also reserves the right to accept or reject any bid without assigning any reason.
3. The auction will be held on "as it is and where it is basis" and lifting, loading and transportation charges will be the entire responsibility of the bidder in whose name the material is released. The delay if any in lying the material shall be at the ~~risk~~ & cost of bidder.
4. The successful bidder shall be bound to lift the material from the premises within 3 days of the date of auction after depositing whole amount and thereafter the responsibility of the Department ceases.
