OFFICE ORDER.

With a view to further strengthen the monitoring of the various activities and development works being undertaken by the Forest Department at the field level, the following Officers are hereby assigned/allotted the Circles to undertake monitoring and inspection of various forest works in the field:-

3.	CCF (IT.)	GHNP, Shamshi


The officers are expected to inspect the circle allotted to them on quarterly basis to ensure effectiveness of the works being carried out in the field. A detailed Inspection Report will be submitted to this office so that the same could be sent to the Government as per Govt. Order No. FFE-B-E(3)63/2014 dated 19.12.2014.

During these inspections following points will receive particular attention:-

- ▶ Qualitative and quantitative assessment of plantations done;
- ▶ Conditions of nurseries and quality of planting stock;
- ▶ ~~Marking of trees to HSEFDC & Resin Tapping works,~~
- ▶ Rehabilitation of Lantana infested areas;
- ▶ CAMPA and CAT Plan works;
- ▶ Preventive steps to stop illicit/illegal felling;
- ▶ Promptness of action in detecting illicit/illegal felling and mining;
- ▶ Office Inspection of designated Circles as prescribed format;
- ▶ Review of compliance of Mandatory Field Inspection Protocol (CFs/DFOs/ACFs & ROs);
- ▶ Specific and time bound issues raised in the Conservator of Forests Conferences etc.

In addition to above, the issues pertaining specifically to Wildlife Units are as under which needs to be commented and reported by Inspecting Officers:

- ▶ Habitat Management; Status of Census Operations; Status w.r.t. Management Plans; Efforts to resolve Man-Animals Conflict; Status w.r.t. Monkey Sterilization; Zoo & Peasantry Management etc.


