




## AUCTION NOTICE

### TERMS & CONDITIONS:

1. Every bidder will have to deposit a sum of Rs. 40,000/- (Rs. Forty thousand only) in the shape of Bank Draft drawn in favour of the DFO Shimla-2 to qualify for bidding which will be refunded at the end of auction except for the successful bidder.
2. The successful bidder will have to deposit 25% of the amount of bid at the fall of hammer and the remaining 75% will be deposited after the approval is given to him and thereafter he will be allowed to start the demolition. In case he fails to deposit the entire amount within 24 hours from the award, all deposited money will be forfeited and tender/bid will be cancelled.
3. The bidder shall have to demolish the building and remove all salvage materials etc. from the premises as per directions of the R.O. Mashobra and hand over the clear site to the Department within 30 days after the date of award. The un-serviceable material / mulba would have to be disposed / dumped in/ at appropriate place / dumping site.
4. The department / DFO Shimla reserve the right to accept or reject the highest bid without assigning any reason whatsoever.
