- 6. All bids must be accompanied by Earnest Money Deposit (EMD) to the tune of Rs.75000/ (Rs. Seventy Five Thousand only) in the shape of FDR of any Nationalized Bank pledged in favour of Divisional Forest Officer, Anni at Luhri with minimum validity/ Maturity of six months. The bids without specified earnest money will be summarily rejected. The EMD of unsuccessful bidders will be refunded immediately after the completion of bidding process whereas the EMD of the successful bidder will be retained in the office and converted into the performance security.
- 7. The performance security will be @5% of lowest responsive bid, after completion of bidding process. The successful bidder bidder will have to deposit the differential amount in the shape of FDR before the award of work order
- 8. The bidder can participate themselves or through their authorized representative at the time of opening of the bids.
