- 2. Since, it has been brought to the notice of the undersigned by some field functionaries that the dates fixed for Monkey population estimation vide the above referred memo are inconvenient to them as the written test for the recruitment of FGs is fixed for 28th June 2015 and the staff are deployed on duty and can't reach back to their head quarters to carry out the estimation process on 29th June.
- 3. In order to facilitate an accurate assessment of Monkey Population, it has been decided that the schedule of Monkey Population Estimation is slightly revised as follows, where as the rest of the schedule of sensitizing etc., will stand as such.

REVISED SCHEDULE OF MONKEY POPULATION ESTIMATION SURVEY:

- 4. On 30th June, 2015 (Tuesday): All forest guards will carry out **a presurvey** of all Monkey troupe locations and estimate population of each troupe.
- 5. On 1st July, 2015 (Wednesday) **the survey** will begin at 7 AM in the morning and will end at 5.30 PM in the evening.
- 6. On 2nd July, 2015 (Thursday), all forest guards will carry out **Post Survey** verification.
- 7. Due to the above modification in the schedule, the due dates for compilation of Monkey survey results shall stand extended further by 2 days i.e.
 - a) Submission of Survey Results by Forest Guards to Range Officers: 5th July
 - b) Submission of Survey Results by Range Officers to DFOs: 7th July.

- c) Submission of Survey Results by DFOs (T) & DFOs (WL) to their respective CCFs/CFs by 12th July.
- 8. Compilation of Survey Results finally by CCFs/CFs (Wildlife) and submission

to Pr.CCF (Wildlife) by 17th July, 2015.
