2. Cover 2: Shall contain "BoQ"/Financial Bid", where contractor will quote his offer for each item.

5. Submission of original documents:  
The bidders are required to submit (a) original demand draft towards the cost of bid document and (b) original bid security/ EMD in the favor of DFO Kullu and other Technical documents in the O/o Divisional Forest Officer, Kullu Forest Division Kullu Distt. Kullu as specified in Key dates on or before 08/08/2019 11:00 AM, failing which the bids will be declared non-responsive.
6. Bid opening Details: the bids shall be opened 08/08/2019 at 11:30 AM in the O/o Divisional Forest Officer, Kullu Forest Division, Kullu Distt. Kullu by the authorized officer. In their own interest the tenderers are advised to be present along with original documents at the time of opening tenders.
7. If it happens to be holiday on the date of opening of bids as specified, the bids will be opened on the next working day at the same time and venue and no separate notice will be given in this regard.
8. The bids for the wok shall remain valid for acceptance for a period not less than 120 days after the dead line date for bid submission.
9. Other details can be seen in the bidding documents. The office inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender.
